

**MINUTES OF THE ANNUAL PARISH MEETING HELD ON 12TH APRIL 2011, AT
7.30 PM IN THE VILLAGE HALL COMMITTEE ROOM.**

1. **Apologies** were received from Cllrs Eldridge, Eassom, Coates, Harlow, Mr & Mrs G. Shenton.

2. **The minutes** of the meeting held on 13th April 2010 were approved after the May 2010 meeting, and then published on the website.

a. **Matters Arising.**

- HQ Trees - this is still ongoing and awaiting legal agreements.
- Pavement parking and dog fouling - attempts have been made to resolve.

3. **CHAIRMANS REPORT 2010/11**

The past year has resulted in a number of matters that will affect the village both now and in the future.

Firstly the Parish Plan Steering Group has made significant advances, despite a serious reduction in their numbers making considerably more work for the few remaining stalwarts. Their initial findings have now been prepared and the next stage will cover how these should move forward. Our thanks go to the Chairman Brian Melling, and everyone involved for all their hard work.

Secondly, as you may be aware, Police Headquarters will totally change in both the short and long term. Within the next nine months virtually all staff will be relocated elsewhere. With the exception of the Communications Centre all remaining land will be sold.

At a meeting at the Town Hall on the 23rd March the Police presented their intentions, and they will now make an application for outline planning permission for two aspects.

1. A change of use from Police to 'RESIDENTIAL CARE'.

2. To obtain permission for the future development of a 'RESIDENTIAL CARE VILLAGE'. If granted they will sell the property to basically the highest bidder. The size of the development under the present plans is intended to be no greater than the floor space of the existing buildings. Final planning permission will be the responsibility of any subsequent owner of the land and properties. The woods and the field opposite Waller and Quarry Close may be sold as separate entities to the main development, but this has yet to be decided. The field is presently protected from residential development.

The Parish Council has dealt with a large number of improvements and repairs, to various areas of the village, the majority of them have been carried out by a number of Councillors in order to cut costs. Thank you to everyone for helping.

By the time of this meeting the footpath from the school towards the island should have been widened to its original width. The footpath towards Kenilworth still needs further work.

There have also been a number of planning issues to be resolved over the year.

May I pass on my sincere thanks to Eileen, our Clerk who has seen a considerable increase in her workload this year, something which needs to be addressed by the new Council over the coming months. Also to our representatives from the County and District Councils Josie Compton, and Susan Gallagher, for their invaluable assistance, and finally to all the Councillors I say thank you for your help and advice over the year.

May I remind all residents of the Parish that as Councillors, we are here for their benefit. If there are any matters you need help with, please contact us. We have a wide area of responsibility, but if we cannot help, we will find someone who can.

4. Financial Report Annual Return 2009/10

The annual return for April 2009– March 2010 was submitted to auditors Clement Keys for inspection in June 2010, and approved in July. The usual notices were displayed at that time and copies of the return are always available for scrutiny. The 2010/11 accounts and annual return will shortly be scrutinised by our internal auditor, and submitted for approval by auditors Clement Keys in July 2011.

For the year 2011/12 the Precept remains the same at £7262, and Concurrent income will be £2980, - income will be £10242.

A balance of £5477.06 was brought forward at 31st March 11, £588.75 of this is the remainder of a grant received from WDC towards the new Steering Committee's expenses whilst undergoing the Parish Plan project.

A large amount of our income is spent on safety and maintenance of the playground, play equipment, and other general maintenance to village areas, as well as annual grants to the Church, and Sports Club. Attempts have been made over the past year to keep costs to a minimum and this has been successful, with a great deal of general maintenance being completed by Councillors.

This year, there will be election charges to take into consideration - even though we will not have to have an election, WDC make a charge to all Parishes, probably for administration! Also the Parish Council has agreed to contribute £500 towards the Village Hall kitchen scheme. Efforts will again be made to keep expenses to a minimum in the current economic climate. The accounts are always available for inspection by appointment.

6. Reports from County and District Councillors

C/Cllr Mrs J Compton.

Cllr Mrs Compton commented that the reality of the spending cuts are now happening, and that WCC accounts for approx 90% of the Council tax and is therefore the largest spender, the reduction in overall departmental budgets will be substantial with £60 million in savings to be made over three years.

Every section has had to take its share, with savings being made in Adult Services, and selling off the remaining Council owned care homes. School Transport grants will be reduced with post 16 education transport cut. County Music Service will have to be self financing. Youth Service budget has been reduced by two thirds, as well as bus services which are not commercially viable which includes many rural areas. 16 libraries across the County are under threat to closure although the mobile service is safe with joint working with Solihull. Street lights in certain roads will be switched off during the hours of darkness, non regulatory carriage markings not being replaced etc. All these proposed alterations to the services are subject to consultation and all budget reductions can be found on the WCC website under the "Facing the Challenge" heading.

The long awaited result of the Atherstone on Stour Fire Enquiry resulted in three senior fire officers being charged with corporate manslaughter and WCC itself charged under the Health and Safety at Work Act.

Warwick Rural West Community Forum, has met regularly with Leek Wootton always being well represented and indeed awarded a grant for a First Responder from their funds during the year.

Cllr Compton summarised by commenting that the last year has been somewhat different as she has had the privilege of being Chairman of the County Council, which has meant that her time has been taken with representing the County both within its borders and also in neighbouring counties. Many functions have been attended with the highlight being the visit of Her Majesty the Queen to open the new Justice Centre in Leamington – locally the Princess Royal visited Lowlands Farm at Shrewley as President of Riding for the Disabled. Her primary function has been of course to chair meetings of the full Council with 61 Councillors names to remember! and she recorded her thanks to the Chairman, Councillors and Clerk for their help and cooperation.

D/Cllr Mrs Gallagher.

Cllr Mrs Gallagher reported on the 4 years since she became a local Councillor, outlining the various problems she was able to deal with including reinstating travel tokens.

WDC now has one of the best recycling services in the country.

Cllr Gallagher was appointed to the Executive last May and given the portfolio of culture and leisure, responsible for parks and gardens, leisure centres, the spa centre, the town hall, open spaces, museums - a very varied and busy portfolio. A new manager at the Spa Centre has resulted in a superb programme with customers flocking back, and new seating in the stalls is to be installed.

In May last year, travellers moved on to a site in Kites nest Lane, which has caused a great deal of problems, however, after two years this is now at the appeal stage, and with the help of WDC and FROG a satisfactory conclusion may be imminent.

Good news – money to restore the Linden Arches on the Pump Room Gardens has been raised by the public and local businesses, to be completed for the Queens diamond Jubilee in 2012.

After four very busy and rewarding years, Cllr Gallagher thanked everyone for their help, and is always available to help solve any problems that might occur.

7. Issues of particular local importance.

PARISH PLAN PROGRESS.

The Chairman Brian Melling and Jonathan Kingston, of the Parish Plan Steering Group reported on progress since the Steering Group was formed in 2009. They will shortly be taking advice from Mr Patalong of WRCC on how to go forward to the next stage of an Action Plan. Some of the main concerns were discussed, as well as details of questionnaire results, which have been published in past issues of the Link. It is felt that more analysis is needed before further progress can be made.

A lack of support from original group members was proving disappointing, adding to the workload of the small Steering Group Committee.

The Chairman thanked Mr Melling and Mr Kingston for attending and reporting to the PC on progress, and wished them well in the future.

Other questions :

- Q - conflicting information from village organisations arise from time to time. It was suggested that efforts could be made to liaise with other organisations. More communication is also needed for non website users.
- Q – is the field adjacent to Police HQ secure? The PC has been assured that it will be.
- Mrs Murdoch expressed thanks for the speedy repair to the footpath steps.

8. There were no other matters raised, the meeting closed at 8.55pm. The Chairman thanked everyone for attending.

As I write the report this year it seems that the reality of the spending cuts is just about to hit us.

Times are not easy in local government and with WCC accounting for approx. 90% of the council tax and therefore the largest spender the reduction in overall departmental budgets is substantial with £60 million in savings to be made over three years.

Every section has had to take its' share with savings being made in Adult Services, with only substantial and critical needs being accommodated, and selling off the remaining council owned care homes, School Transport grants reduced with post 16 education transport cut, County Music Service will have to be self financing. Youth Service budget has been reduced by ^{75%} a third which will mean that Youth Workers will have to manage more than one location, Bus Services which are not commercially viable, which includes many rural areas reduced, Library provision, 16 Libraries across the County under threat to closure although the Mobile Service is safe with joint working with Solihull, but this will mean some reduction in rounds. Street Lights in certain roads will be switched off during the hours of darkness, non regulatory carriage markings not being replaced etc. All these proposed alterations to the services are subject to Consultations which are running at the moment and all Budget reductions can be found on the WCC Web Site under the Facing the Challenge heading. Many staff have left the authority either with redundancy or early retirement and Strategic Directors have now been reduced to three plus the Chief Fire Officer I could go on but I am sure you have realised that times are tough.

We have had the long awaited result of the Atherstone on Stour Fire Enquiry with has resulted in three senior fire officers being charged with corporate manslaughter and WCC itself charged under the Health and Safety at Work Act.

Warwick Rural West Community Forum, of which I am co chairman at the moment has met regularly with Leek Wootton always being well represented and indeed awarded a grant for a First Responder from their funds during the year. Many matters of general concern are voiced at these meetings, the last meeting in February addressing changes to the NHS. The Police always attend and have given details of the alterations they are making in the light of their Budget cuts with the closures of Warwick Police Station, Lapworth and Hatton Police Posts and the move from the Headquarters at Leek Wootton .

The last year has been somewhat different for me as your County Councillor as have had the privilege of being Chairman of the County Council. This has meant that my time has been taken with representing the County both within its' borders and also in neighbouring counties. Many functions have been attended with the highlight being the visit of Her Majesty the Queen to open the new Justice Centre in Leamington – locally the Princess Royal visited Lowlands Farm at Shrewley as President of Riding for the Disabled. My primary function has been of course to Chair meetings of the Full Council – this has been a difficult year as you can imagine with several awkward debates to handle and 61 councillors names to remember, however this all comes to an end in the middle of May so back to the back benches.



I have attended meetings of the Parish Council regularly and would like to place on record my thanks to the Chairman, Councillors and clerk for their help and co operation.

I have now been ^{you} District Councillor for 4 years, does't time fly when you are having fun, but election time has come around again so I have been looking at what went on during that time. 4years ago the main problems in my area were Travel Tokens, as the rural areas had lost them due to the last administration had taken them off us, and the rubbish collections, well as you now know I was able to re instate the Travel Tokens, not without a great fight, and I believe that now with the cut backs within the County, and bus services being reduced they will be even more important to the rural areas.

As for the rubbish collections, after a few teething problems we now have one of the best re cycling sevicees in the country, and I think you will agree that during the awful winter we had the sevice was superb.

When I was first elected I had a very hard act to follow, Jose Compton had represented you for many years, but I was quickly thrown into planning disputes, getting children on the right bus for school, and many local issues, you do in fact spend a great deal of time away from home, this allows my husband to watch as much rugby and cricket as he wants.

Last May I was appointed to the Executive and given the Portfolio for Culture and Leisure, this is a huge Portfolio but very interesting, it means that I am responsible for all the Parks and Gardens, the Leisure Centres, the Spa Centre, Town Hall, open spaces, Museum, trees, so you can see that it is very varied, going back to the Spa Centre, I think you will all remember that it appeared to be under the threat of closing, well that was what the Leamington Courier said, not really true, but we did have to have a long look at it.

We bought in a new manager Antony Flint from the Belgrade in Coventry, what a find he was, We gave him a very small amount of money to give it a face lift and now it looks great, the new programme is superb and the customers are flocking back, and hot off the press we are re placing the seating in the stalls of the main theatre and the studio.

Now last May bank holiday was a disaster day for my ward, if you remember, and how could you forget, I had a phone call from a resident in Kites Nest Lane, saying that travellers had moved on to a site in Kites Nest Lane, I jumped in my car straight away and drove to the site, where I watched with horror as lorry after lorry swept on to the field dropping hard core, within 12hrs it was no longer a lovely pony paddock in a leafy lane, but a car park, I knew then that we were looking at 2years of travellers, well we are now at appeal stage and with the help of the District Council and FRoG we hope to see the end of the fight.

I shall end with some good news, I have been working with the Friends of the Royal Pump Room Gardens to raise money to restore the Linden Arches on the Pump Room Gardens in Leamington Spa, the District gave us some money, but all the rest has been donated by the public and local businesses, we have now awarded the contract to a local firm in Warwick, and we hope to have them completed for the Queens Diamond Jubilee in 2012.

The last 4 years have been very busy, but very rewarding, I have met some wonderful people, and I hope I have been able to be of help to some of them, I would like to thank my 3 parish councils for all the help that they have given me, and as always any problems you can always contact me by email, phone letter, or just knock on my door.

Leek Wootton History Group

The past year has seen the History Group continuing to be active although not perhaps as publicly as in 2009.

The Wise and Waller Map was published by Warwickshire County Record Office (WCRO) and a copy was distributed to every household in the Parish.

The Group held its first formal AGM in May 2010 and a number of potential project subjects were discussed.

A trip to the Imperial War Museum was organised in November and sixteen people enjoyed a very interesting visit to this extensive museum.

Our Chairman acted as volunteer co-ordinator of a Leamington History Group (LHG) project to transcribe the letters of Edward Willes, and some members of LWHG assisted with transcribing and checking. This project was undertaken by LHG with the assistance of WCRO.

The Group has recently published a booklet entitled *A History of Woodcote*, which is available to buy, and twenty copies have been given to All Saints' School.

Much time has been given to making an application to the Heritage Lottery Fund (HLF) to finance a project planned around the Diary of Doreen Wright, which she wrote from May 1940, when her husband Gilbert went missing over France, until December 1942. In March we learned that we had been awarded a grant of nearly £37,000 and are about to start on the project in earnest.

We will be looking for volunteers to undertake various elements of the project. Anyone interested in being involved will be very welcome to our AGM at 7:30 pm on 5 May at All Saints' School, at which there will be a presentation on the project.

2011/2012 is therefore going to be a much more active year for the History Group. We also have a plan to try to organise a joint visit with the Horticultural Society to Hill Close Gardens in Warwick; more details in due course.

Annual Report to Leek Wootton Village Hall Committee

This year sees the tenth anniversary of the reformation of Leek Wootton Women's Institute and we intend to mark the occasion at our Annual General Meeting in October. The past ten years has seen the group go from strength to strength, reflecting the Women's Institute motto of 'Inspiring Women' whichever way you take it!!!!

We regularly welcome visitors to our varied programme of events and now have more than fifty members. The year began with an insight into buying and selling at auction, a talk on the perils and rewards of selling the family heirlooms. In the spring Tamsin Rosewell brought the new Elizabethan Gardens at Kenilworth Castle to life for us, describing the sights, smells and sounds and telling the secrets behind the symbolism in the flowers and carvings. Later in the year we learnt how to make hats from some banana fibre, some spray glue, a corset stay and a length of Clingfilm. On a more serious note we learnt of the good work done by a local women's refuge and debated the national resolutions on mandatory labelling of country of origin on all meat, poultry and fish products sold in this country. We joined with other WI groups in the Warwickshire Federation Quiz, which we won, and in a display of Irish dancing – deafening!

The gardening and walking groups were hampered by the poor weather although the walkers managed an evening walk by the canal and the gardeners made the garden pretty and welcoming. We had eight trips to the theatre to see shows as diverse as West Side Story at Warwick Arts Centre and the ballet Cinderella at Birmingham Hippodrome. The reading group read and discussed seven books with varying levels of interest. We also managed five meals out at venues as varied as a Chinese restaurant and Coventry Guildhall.

This year's programme offers different topics and different outings but the same welcome and degree of interest and friendship to all members.



2010 was another good year for the Society and we continue to enjoy splendid support from the local community.

Tom and Margaret Powell, ably assisted by Renee Perkins, organized another successful outing on Sunday 20th June to Arley House and Gardens in Cheshire. Margaret and Tom Powell pay particular attention in their preparation for the outing seeking a venue of interest to those joining the coach along with coffee stops and available restaurant facilities at the venue. They do feel that this trip was a little on the long side and service in the restaurant left a little to be desired. In their inimitable fashion these factors will have a bearing on the next outing.

The Show, on 21st August, attracted fewer exhibitors than 2009 and this was put down largely to adverse weather conditions. Income was however only slightly down with the cake stall and raffle making significant contributions. Exhibits at a level that we have come to expect and these are undoubtedly a major attraction to the show visitors. Support continues from local businesses in the form of prizes for the raffle and we are grateful for that support. Our relatively strong financial position enabled us to make donations of support to the Warwickshire and Northamptonshire Air Ambulance, LINK Magazine and the Social Club Tractor. Keven Meredith, who passed away last year provided the Annual T K Meredith Award for the best exhibit in the Floral Section, the Committee has agreed to continue the Award as the T K Meredith Memorial Award. However the Trustees of Mr. Meredith's estate agreed to provide continuing support for the Award for the next 20 years and have provided those funds in one payment, which now rests in our accounts. A letter of thanks was sent to the Trustees.

The Christmas buffet on 11th December, held in the Village Hall, again enabled the Committee members to demonstrate their appreciation to those who had supported the Society over the year. Food and drink was supplied by Committee Members and all attendees enjoyed a pleasant social evening. That support manifests itself in a number of ways through donations, prizes and assistance, particularly at the show.

Looking forward with notes for your diary in 2011

The Outing will be on Sunday 5th June and we will be the guests of the owners of The Burrows Garden and Snelston Hall both of which are near Ashbourne in Derbyshire. The journey will not be as long as last year and lunch can be preordered which means service should be at the standard required. Renee Perkins is taking bookings, costs being £20 for the outing and £8 for the lunch, if required.

The Annual Show will be held on Saturday 20th August and we may see some interesting additions to the Schedule. Photographic categories will be 'A favourite plant' and 'A friend in the garden'. Angela Guest will be orchestrating the event, as she has successfully achieved over many years.

My thanks to all who have supported the Society over the past 12 months especially the members of the Committee who have given unstinting support. Special thanks are due to our Secretary Mary Murdoch for her boundless energy and support, as she is kept busy running the Society and in keeping me on the straight and narrow. Christine Hurcomb is ideal as Treasurer, as being a Scot she keeps tight hold on the purse strings and keeping our accounts in order,

I have to again conclude with my annual appeal. Our constitution provides for a committee of 16 members, including the Officers, and we are currently at 14 members. An example of the commitment shown by current members is demonstrated by Margaret Powell who has served on the Committee for 42 years. If we are to continue with the successes enjoyed by our Society we must recruit new members, particularly younger members who will be able to safeguard succession within the Committee.
