9.3. LW&GC Environment Group (Cllr Elsy)

Hedge & Tree Surveys

Environment Group has asked the Clerk about 'at risk' areas, i.e. areas that have been earmarked for development, around the parish. Whilst the only areas included in the last Local Plan have been developed (The Cedars at The Warwickshire) and Woodcote (Police HQ), the Clerk sent a link to the South Warwickshire Local Plan [SWLP] 'Call for Sites' website page, because this shows areas that, whilst not currently earmarked for development, could be prioritised as being at risk in the future.

9.3.1. Recreation Ground Biodiversity Project

A temporary information sign has been put in the car park to tell people about the project and reason for the log piles, etc.

Trees

Clerk has requested 3 of each of the species listed on the Biodiversity Plan from the HS2 Surplus Tree/Hedge Saplings Donation scheme. The PC awaits the outcome of the donation scheme, but expects these to be whips.

Cllr Elsy to look into ordering required trees in addition.

- **10.1.** Warwickshire County Council
 - Reminders: Fire Service Consultation ends Sunday and Household Support Grant now live
 - Cllr Elsy asked about further devolution for Warwickshire. The County has received a briefing (embargoed until the budget announcement) and will forward to the Clerk to circulate.
 - The Chair raised issue of littering and WCC highways' or contractors' ironwork being amongst littering, particularly at the A46 Gaveston roundabout southbound sliproad. This has been raised by a resident. C/Cllr Redford to look into this. [UPDATE 13/03/2024: D/Cllr Redford wrote, "I understand from WDC Contract Services that your query regarding the fly-tipping and rubbish on the A46 will be cleared between 18 -28 March."]
- 10.2. Warwick District Council
 - Household Support Grant Families and households in Warwickshire can apply, whether they use prepayment meters, pay by direct debit or on receipt of a bill.
 Residents are invited to contact the local welfare scheme team for confidential discussion. This is continuation of the help to pay utility bills.
